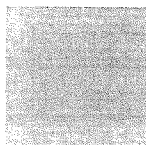

Congratulations on your COPS Hiring Recovery Program (CHRP) award! This letter is to inform you that the registration period for your Recovery Act grant on the FederalReporting.gov website has begun.
