Preliminary Plat Submittal: Applicant must submit 5 full size copies and 5 half size copies of the preliminary plat and the supplementary information specified in Sections 1127.06 to 1127.09, inclusive, to the City of Bucyrus Engineering/Zoning Department, and **a copy must be submitted to the city's engineering firm by 5:00P.M. on or before the application deadline.** Failure to submit any item as listed on departmental checklists, or any additional information that might be requested, on or before the deadline will result in the application being held until the next scheduled meeting of the Planning Commission.

Final Plat Submittal: Applicant must submit 5 full size copies and 5 half size copies of the final plat and the supplementary information specified in Sections 1127.16 to 1127.18, inclusive, to the City of Bucyrus Engineering/Zoning Department, and **a copy must be submitted to the city's engineering firm by 5:00P.M. on or before the application deadline.** Failure to submit any item as listed on departmental checklists, or any additional information that might be requested, on or before the deadline will result in the application being held until the next scheduled meeting of the Planning Commission.

Additional information:

Prior to granting approval of the final plat, the subdivider shall conform to 1127.15 of the Planning and Zoning Code.

Prior to the issuance of a building permit from the City, the applicant shall pay the planning and engineering review fee pursuant to 1129.18 of the Planning and Zoning Code.
