CANVASSING OR SOLICITATION IN VIOLATION OF NOTICE: It is unlawful and shall constitute a trespass for any person to go upon any premises and ring the doorbell upon or near any door, or rap or knock upon any door, or create any sound in any other manner calculated to attract the attention of any occupant of such residence or place of business for the purpose of securing an audience with the occupant(s) thereof and engage in canvassing in defiance of the notice exhibited at the residence or place of business. 3. TIME LIMIT ON CANVASSING OR SOLICITATION: It is unlawful and shall constitute a nuisance for any person to go upon any premises and ring the doorbell upon or near any door of a residence located thereon, or rap or knock upon any door, or create any sound in any manner calculated to attract the attention of any occupant of such residence, for the purpose of securing an audience with the occupant(s) thereof and to engage in canvassing prior to 9:00 a.m. or after 9:00 p.m. Monday through Sunday or on a State or national holiday.
